

General Church Meeting

Sunday 22nd May 2028

Minutes

Attendance (28) and apologies (12) (see Appendix 1).

Chair: Raj Patta (RP) Secretary: Deborah Symmons (DS)

1. Linda Fleming (LF) opened the meeting in prayer

2. Minutes of the meeting held on 27th February 2022

These had been previously circulated. They were accepted and signed by RP.

3. Matters arising

Life and witness of the Church

A discussion on the life and witness of the Church post-pandemic was led by Graham Adams (GA) at the February meeting. RP read out some follow-up questions which GA had sent by e-mail (as he was unable to attend the meeting). The first was a request for an update on what had happened since February. Carol Jack, Anne Wilde and Alan Scott (AS) had offered to host regular small meetings. Sharon Heginbotham (SH) will promote these via the newsletter to gauge interest. In addition, SH offered to co-ordinate walk and talk sessions; and LF and JoAnne Roy (JR) have set up a bereavement group for those within the church and the wider community. GA's second suggestion was to explore 'who we are' as a church now. There was a general discussion as to whether any more action was needed in response to GA's concerns. The consensus was that there was much going on within the church – new activities and old. Opportunities for one-to-one conversations with those feeling isolated or disconnected would be taken up by Pastoral Visitors and any need for further support would be relayed to the Church staff team. It was noted that new people were joining the church and that the pastoral support network is strong. AS reassured the meeting and spoke of the welcome he had felt as a new member joining towards the end of the pandemic.

Sunday coffee

SH had not received enough offers of help to set up a regular rota. Instead there is a sign up sheet. So far there had been coffee each Sunday. If there is a week with no volunteer then there won't be any coffee that week.

4. Report from the Leadership Team

A report from the Leadership Team was circulated in advance (see Appendix 2). There were no questions. The team were thanked for their work.

5. Report from the Property Committee

A report from the Property Committee was circulated in advance (see Appendix 2). Roy Dudley Southern provided an update with regards to the roof repairs. The scaffolding firm have been unable to commit to a definite date to start the work. If the start of work is delayed such that it cannot be completed before Christmas, then it will be deferred until 2023. There were no further questions. The Property Committee were thanked for their work.

6. Finance Officer's report

The finance officer's report and the accounts for September 2021 to March 2022 were included in Appendix 2. SH also provided an update on communications with Epworth Investments about transferring some of our investments. There were no questions. SH and the Finance Committee were thanked for their work.

7. Community Worker Report

JR gave a verbal report. Much of her time prior to Easter was taken up with organising the yurt, on behalf of the Circuit, in the centre of Stockport. She thanked church members for their support of the yurt activities. Messy Church and Muddy Church sessions were held in May. JR encouraged church members to support these events. She reassured members that, despite their names, little mud or mess was involved! The afternoon tea dance will restart in July. There were no questions. Members applauded JoAnne and thanked her for her work.

8. Worship Committee Report

A report from the Worship Committee was circulated in advance (see Appendix 2). There were no questions. The Worship Committee were thanked for their work.

9. Minister's concerns

RP reported that he is now in his 5th year in the United Stockport Circuit and that his invitation is coming up for renewal. Members thanked him for his service and applauded him. RP also reported on activities during Lent and Holy Week – the distribution of over 10,000 Easter cards; the coffee and hot cross bun distribution from the Plough; the Good Friday Walk of Witness (which had over 100 participants). He thanked members for their support.

10. News from the Circuit and URC

A deacon, Janet Amey, will be joining the Circuit staff in September. She will be based in the town centre (Tiviot Dale). She and Raj will form a team serving the town centre, Heaton Moor, Heaton Mersey and Edgeley. Discussions about the future of Tiviot Dale are ongoing now that NHS Test and Trace have moved out. For now, the circuit office is based there. The Circuit have leased space at Bright House in the town centre. The space is renamed 'Cactus'.

11. Any other business

DS read out a letter from Jim Lowe in which he tendered his resignation as Honorary Treasurer, Chair of the Finance and Fundraising Committees, and member of the Leadership Team. Members expressed their appreciation of his many years of service and asked that a gift and card be sent to Jim. DS will write the card and SH source the gift. As the church must have an Honorary Treasurer, Carol Jack has agreed to take on this role on a temporary basis. The Leadership Team vacancy will be advertised to the membership and an election held at the next church meeting. The other vacancies created by Jim's resignation will be considered and nominations made by the Leadership Team.

Sue Jones asked for volunteers to join the Communion Steward rota. Jean James, Carol Jack and Louise Lee offered.



The Leadership Team meets monthly with the exception of August and December, during which an emergency meeting can be convened if required. The regular agenda comprises any news, updates, changes and problems with regard to Finance, Property, Community Work, Worship, Pastoral Work, Lay Work, Circuit feedback, URC Feedback and Methodist Conference feedback, with an opportunity to discuss any other business that might arise.

Since the last Church Meeting in February 2022, there has been 1 Leadership Team Meeting.

2022

February: There was no Leadership Team meeting.

March:

Michael Ball and Jan Southworth were welcomed onto the Leadership Team. Ian Shore and Mark Field have completed their terms and Arnold Jones has resigned; thanks were given for their services to our church.

The Property and Worship Team will provide respective Reports for the church meeting. Sharon Heginbotham and JoAnne Roy have started their Worship Leader studies with Andy Stoker; Carol Jack and Deborah Symmons are their respective mentors.

The Palm Sunday Circuit Service in St Peter's Square saw around 200 attendees, the atmosphere was good and deemed a success by all who were there.

The Easter services in the Moor and the walk of witness were well attended.

There was a question at the last meeting about increasing Lay Worker hours in our church; however, following a detailed examination of job descriptions, it was felt that our church is in a good position regarding lay employees.

April:

The meeting was cancelled at short notice as a quorum could not be reached; the May meeting is next week.

PROPERTY REPORT

The Property group have met twice since the last Church Meeting

Our meeting on March 18th was just a regular bi-monthly meeting to discuss general matters.

Amongst these were that there were problems with the office phone system brought about by the rearrangement of our administrative staff's work positions. A solution was found, but there are still quirks with this. So it has been decided to purchase some new equipment to better cope with the demands of daily business.

We also have been having ongoing maintenance and repair problems with vacuum cleaners, resulting in the purchase of one new Henry vacuum, and the disposal of the two failing units.

The upgrade work upon the lift has finally been completed.

Our meeting on the 22nd February was with the architect and builder who are going to be involved with the roof project, to discuss the finer points, including legal requirements, insurance cover and timescales etc.

The more observant of you will have noticed that the scaffold build has not yet commenced. This is due to manpower problems at the scaffold company. We now hope that this will commence in early June, although no exact date has been proffered by them. Once the scaffold build has commenced we anticipate that the length of the project could take up to four months.

Finance Officer Report Church Meeting 22nd May 2022

The financial position of the church is improving as covid restrictions are being lifted.

Lettings

The lettings have returned to pre covid levels, in fact we have a couple of new groups who are regularly using the building.

There are very few time slots now available for booking, which is good. The hall is being booked regularly for parties as well .

Giving

The amount received through giving either on a Sunday or through Standing Orders, have remained constant through the last 3 years. Thank you for your continued support for the work of the church.

Utilities

There is a large difference from last year to this year , as the invoice from the Circuit for the Gas and Electric hadn't been paid at the time of doing the accounts. Even though fuel costs are raising the church is protected at the moment as we are on a fixed rate until October . The circuit is looking at getting the best deal they can when the contract comes up for renewal .

Review of our reserves

The finance group has been working with the URC, to explore better ways to ensure we are getting the best returns on our investments. This has involved meeting with 2 investment companies to see what they can offer us. The group decided to go with Epworth who are an ethical investment company. The are owned by CFB, Central Finance Board of the Methodist Church. https://www.epworthinvestment.co.uk/ if you wish to read about them.

Before deciding where and how much to invest, the finance group has reviewed the financial position of the church for the next 5 years. Once this has been agreed by the leadership team, this could be shared at a future church meeting.

I will be attending the meeting, so any questions can be raised then about the financial position of the church .

The Worship Committee comprises Raj Patta, Graham Adams, Carol Jack, Louise Lee, Deborah Symmons, Sharon Heginbotham and JoAnne Roy. Anne Wilde and Paul Brewerton have recently joined us. We meet approximately once a quarter. Our first task is usually to review the services for the last quarter – particularly 'special' services such as Christmas and Holy Week services. We also draft a plan for the next quarter. This mainly involves scheduling the communion services, Super Sunday and special services according to the season. In line with URC tradition we fill approximately half the services by direct invitation. The other half need to dovetail with the Methodist Circuit plan. We also take responsibility for organising short study courses – usually a couple of times a year. The most recent was the Lenten study course which took place after the service on Sundays. We also have general discussions about forms and styles of worship and the spiritual needs of the congregation.

Time to Reflect

To live with your sister as an adult is a complicated dynamic, (believe me I know), division of labour never seems fair to either sister and of course you both have your own set of priorities. So, I feel for these two sisters, Mary who wants nothing more than to sit at the feet of her Lord and learn and Martha who is desperately trying to be the good hostess and care for her guest.

Martha is clearly frustrated by the lack of help from her sister and I have no doubt like all good sisterly living arrangements she made her feelings clear. Not of course by walking over and asking for Mary's help because she really shouldn't have to ask, Mary after all knows she should be helping. No, the sisterly way to deal with this is to ensure your sister knows you are annoyed by her failure to play her part as you expect. You ensure she is aware that you are working hard by being obvious in your work. You put dishes down firmly so you can be heard working, you make sure your sister can see you rushing back and forth and of course you grunt, groan and sigh so she can hear your pain at the situation. It

takes a lot of time and effort to do it right and not only be noticed but guilt your sister into performing her share of the duties but it usually works.

Mary however ignores Martha's efforts and so Martha breaks a rule of both sisterhood and Jewish hospitality, she tries to get her guest to takes sides in their dispute and I'm sure she's disappointed when he does so by taking Mary's side. Martha is told she is "distracted by many things" while Mary is described as having "chosen the better part".

Its not that Jesus thinks Martha shouldn't welcome or care for her guest it's that she's become so distracted by the duties, her annoyance at Mary and her search for attention, she has forgotten to actually pay her guest the attention he deserves and listen to his words.

The need for others to see how poor Martha must do it all while her sister does nothing has eclipsed Martha's need to see and hear Jesus, she's so busy trying to get everyone to notice how hard she is working to welcome the Lord she isn't paying him any real attention at all.

So, what happens, does Martha choose the better part as well, drop her duties and sit at the feet of the Lord or return to her hostess duties and try to concentrate on her tasks rather than Mary's lack of involvement. We'll never know, Luke doesn't feel the need to conclude the story.

I like to think the sisters sat together at the feet of their Lord and listened before both getting up and doing the washing up but I'll never know.

What I do know is that all of us have a little of Mary and a little of Martha in us, we have so much to do with the demands of family, world and church and we sometimes wish others would notice just how much we do and maybe appreciate it or even help us with it. But what we need, what we really need and

sometimes allow ourselves is to stop, sit in the presence of our Lord and listen to his voice.

The washing up is going nowhere, the dust will not grow legs and walk, the lawn will still need mowing tomorrow so when Jesus comes close and speaks to you stop, listen, be with him, it is the better choice.

Take a time to sit quietly
